

Grantmaking organizations in the U.S. and Canada offer billions of dollars in nonrefundable funding, and the *Annual Register of Grant* SupportTM 2014 provides detailed information on grants and programs available to individuals and organizations seeking the following: scholarship support to obtain an undergraduate or graduate degree; internships to those entering the initial stage of professional experience; residencies to develop professional skills; fellowships for those wanting to advance their careers.

Organizations offering support can be located based on their subject matter (the American Institute of Certified Public Accountants, the American Medical Association Foundation), ethnic and special population groups (Korean American Scholarship Foundation, Women's Education and Research Institute), geographic location (Massachusetts Office of Student Financial Assistance, Missouri Department of Higher Education), or a combination of categories (North Dakota State Board for Indian Scholarships, Chinese American Medical Society).
